Key messages

BTG ขาดทุนสุทธิ์ 656 ล้านบาทใน 4Q66 (-137% YoY, จากขาดทุนสุทธิ์ 784 ล้านบาทใน 3Q66) ดีกว่าที่เราคาด ใว้วาจะขาดทุนสุทธิ์ 691 ล้านบาท และดีกว่า consensus ที่ กาดว่าจะขาดทุนสุทธิ์ 687 ล้านบาท เพราะสัดส่วน SG&A ต่อยอดขายลดลง ทั้งนี้ BTG ใช้กลยุทธ์คุมต้นทุน ซึ่งทำให้สัดส่วน SG&A ต่อยอดขายต่ำกว่า 10% อย่างไร ก็ตาม เนื่องจากราคาหมูที่ตกต่ำในประเทศไทยและ เวียดนาม ทำให้ BTG ยังคงมีผลขาดทุนในไตรมาสนี้ เรา มองว่า BTG ยังขาดปัจจัยกระตุ้นในระยะสั้น เพราะผล ประกอบการมีแนวโน้มจะถูกกดดันจากราคาหมูที่ตกต่ำ อย่างต่อเนื่องใน 1Q67F

ผลประกอบการ 4Q66: ขาดทุนน้อยกว่าที่คาด

Event

BTG ขาดทุนสุทธิ 656 ล้านบาทใน 4Q66 (-137% YoY, จากขาดทุนสุทธิ 784 ล้านบาทใน 3Q66) ดีกว่า ที่เรากาดไว้วาจะขาดทุนสุทธิ 691 ล้านบาท และดีกว่า consensus ที่กาดว่าจะขาดทุนสุทธิ 687 ล้านบาท เพราะสัดส่วน SG&A ต่อยอดขายลดลง ทั้งนี้ ผลขาดทุนสุทธิในปี 2566 อยู่ที่ 1.40 พันล้านบาท (-118% YoY) โดย BTG ประกาศจ่ายเงินปั้นผล 0.25 บาท/หุ้น (กำหนดขึ้น XD วันที่ 13 มีนาคม 2567) คิดเป็น อัตราผลตอบแทนจากเงินปั้นผลที่ 1.2%

Impact

ราคาหมูที่ยังตกต่ำเป็นอุปสรรคสำคัญ

ยอดขายลดลง 8% YoY เหลือ 2.74 หมื่นลานบาท เนื่องจากราคาขายลดลง โดยเฉพาะราคาหมูในประเทศ ไทย และ กัมพูชา อย่างไรก็ตาม ยอดขายยังเพิ่มขึ้น 2% QoQ จากยอดขายจากในธุรกิจเกษตร ใน ขณะเคียวกัน GPM ลดลง 9.8ppts YoY เหลือ 8.5% เพราะ margin ของธุรกิจอาหาร และ โปรตีนรวมถึง ธุรกิจตางประเทศลดลง อย่างไรก็ตาม GPM ของธุรกิจเกษตรยังเพิ่มขึ้นทั้ง YoY และ QoQ ซึ่งชวยหนุน ให้ GPM โดยรวมเพิ่มขึ้น 0.3ppts QoQ ทั้งนี้ สัดสวน SG&A ตอยอดขายอยู่ที่ 9.6% ดีกวาที่เราคาดไว้มาก (-1.5ppts YoY, -1.3ppts QoQ) เนื่องจากบริษัทคุมต้นทุนได้อย่างมีประสิทธิภาพ

BTG บันทึกกำไรจากสินทรัพย์ชีวภาพ 14 ล้านบาท (จากที่เราคาควาจะขาดทุน 10 ล้านบาท) จากที่ ขาดทุน 5 ล้านบาทใน 4Q65 และ 23 ล้านบาทใน 3Q66 ในขณะที่ค่าใช้จายดอกเบี้ยเพิ่มขึ้น 26% YoY และ 23% QoQ เป็น 209 ล้านบาท เนื่องจากยอดหนี้ที่มีภาระดอกเบี้ย และอัตราดอกเบี้ยสูงขึ้น

Valuation and action

เรายังคงคำแนะนำขาย BTG โดยประเมินราคาเป้าหมายปี 2567 ที่ 18.00 บาท (อิงจาก PER ที่ 12.8x) เรา มองว่า BTG ยังขาดปัจจัยกระตุ้นในระยะสั้น เพราะผลประกอบการมีแนวโน้มจะถูกกดดันจากราคาหมู ที่ตกต่ำอยางต่อเนื่องใน 1Q67F
